

**CALEDONIA COUNTY FAIR
DEMOLITION DERBY**

**PARENTAL CONSENT, TO ACCOMPANY
THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION OF my minor child (“the Participant”) being permitted to enter for any purpose any RESTRICTED AREA (as defined in the General Release and Waiver of Liability and Indemnity Agreement associated with this event), or of being permitted to compete in, officiate at, observe, work for, or for any purpose participate in any way with the event, I agree as follows:

1. The Participant and I will each be bound by the terms of the General Release and Waiver of Liability and Indemnity Agreement associated with this event, and will each sign the same;

2. I know the nature of the event, and of demolition derbies in general, and I know the Participant’s experience and capabilities, and I believe the Participant to be qualified to participate in the Event.

3. I fully understand and will instruct the Participant that: (a) the event is VERY DANGEROUS, and that participation in the event and/or entry into the Restricted Area involve RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, AND/OR INJURY TO PROPERTY (“Risks”); (b) these Risks and dangers may be caused by several factors, including but not limited to the following: the Participant’s own actions or inactions, the actions or inactions of others participating in the Event, the rules of the event, the condition and layout of the premises and equipment, or the negligence of the “Releasees,” as defined in the General Release and Waiver of Liability and Indemnity Agreement associated with this event; (c) there may be other risks not known to me, or that are not readily foreseeable at this time; (d) the social and economic losses and/or damages that could result from those Risks COULD BE SEVERE AND COULD PERMANENTLY CHANGE THE PARTICIPANT’S FUTURE.

4. I consent to the Participant’s participation in the event and/or entry into the Restricted Area, and hereby accept and assume all such Risks, known and unknown, and assume all responsibility for the losses, costs and/or damages following such injury, disability, paralysis or death, even if caused, in whole or in part, by the negligence of the Releasees named in the General Release and Waiver of Liability and Indemnity Agreement associated with this event.

5. Pursuant to the General Release and Waiver of Liability and Indemnity Agreement associated with this event, I RELEASE and DISCHARGE and COVENANT NOT TO SUE the Releasees from all liability to me, the Participant, and our personal representatives, assigns, heirs and next of kin, for any and all claims, demands, losses or damages on account of any injury, including, but not limited to, personal injury, disability, paralysis, death or damage to property, causes or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise.

6. I further agree to INDEMNIFY and SAVE and HOLD HARMLESS the Releasees and each of them from any litigation expenses, attorney’s fees, loss, liability, damage or cost they may incur due to the claim made by myself, the Participant, or anyone on the Participant’s behalf, against any of the Releasees, whether the claim is based on the negligence of the Releasees or otherwise.

7. I sign this agreement voluntarily, on behalf of myself and my minor child.

I HAVE READ THIS PARENTAL CONSENT, AND THE GENERAL RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, AND AGREE TO BE BOUND BY ALL. I UNDERSTAND THAT BY SIGNING BELOW I GIVE UP SUBSTANTIAL RIGHTS I AND/OR MY MINOR CHILD WOULD OTHERWISE HAVE TO RECOVER DAMAGES FOR LOSSES OCCASIONED BY THE RELEASEES’ FAULT, AND SIGN IT VOLUNTARILY AND WITHOUT INDUCEMENT.
