Rules and Regulations

1. All riders under the age of 18 are required to wear a helmet at all times while mounted on a horse.
2. A 2018 negative coggins test and rabies certificate is required and must be present at the time of unloading and if you are from out of state a health certificate is required.
3. No re-runs for defective equipment.
4. Failure to complete the pattern, knocking over an obstacle, and completing the pattern incorrectly will result in a disqualification. Ring judge's ruling is final.
5. Riding boots with heels are required no sneakers or shoes without heels will be allowed.
6. Any horse that cannot be controlled in or out of the ring and is deemed a threat to the public will be disqualified and the contestant will be asked to leave, no refunds.
7. No abuse to your horse will be tolerated. Bats, crops, and spurs are allowed but excessive use will not be tolerated.
8. No checks will be accepted at the day of the show, cash only for entries.
9. Please preregister by 8/15/18, send your check and a self-addressed stamped envelope to Brenda Tanner (address on entry form) so she can send you a ticket to get through the gate at no charge. This ticket is just an exhibitor pass if you wish to go on rides or look around the fair you can upgrade this for an additional \$10. *****IF YOU HAVE NOT PREREGISTERED BY THIS DATE THERE WILL BE A \$10.00 LATE FEE IF YOU WANT A TICKET TO GET THRU THE GATE*****
